Individuals declaring such status must present, upon demand, an audited financial statement in support of the claim of eligibility; failure to do so will be deemed a violation. Misrepresentation of eligibility under this provision will subject an individual to disciplinary action under GR1307.6, GR1307.8, GR1308.3 and Chapter 6. Amateur certification under this provision is valid for Eventing competitions only and does not confer Amateur status for participation in any other Breed or Discipline.

USEA HORSE LIFE REGISTRATION POLICY

All horses competing at the Preliminary level and above must be registered at Full Status. All Young Event Horses and Novice and Training level horses moving up to Preliminary must upgrade to Full Status.

- **Future Event Horse:** Registration for yearlings, two- and three-year-olds competing in FEH Tests: **\$25.00**
- **Young Event Horse:** Registration for four- and five-year-olds competing in YEH Tests, and Novice thru Training level: **\$40.00**
- **Beginner Novice Horse:** Registration for BN horses to be considered for USEA high score leaderboards, year-end awards and/or qualifications for USEA Championships: **\$40.00**
- **Limited Status:** Registration for horses competing at Novice and Training levels only: **\$40.00**
- **Upgrade to Full Status:** Upgrade Novice and Training horses to compete at the Preliminary level and above: **\$110.00**
- **Full Status:** Registration for horses competing at Preliminary level and above: **\$150.00**

USEA Horse Life Registration and Year-End Awards Policy:

Beginner Novice Horses: Registration for horses competing at the BN level is not required **EXCEPT** where the owner/rider wishes the horse and rider to be considered for USEA high score leaderboards, year-end awards, and/or qualifications for USEA Championships. Award points and qualifications are not retroactive.

USEA MEMBERSHIP CATEGORIES

A rider competing in any USEA registered competition, at any level, must be a current USEA member, and have an approved and current medical armband. Event organizers may waive the USEA membership requirement at the **BEGINNER NOVICE LEVEL ONLY**. In such cases, non-members will be required to pay \$25.00 at each competition they enter.

Riders competing at Novice level or above (Beginner Novice level exempt) must register their horses with the USEA, and must be a Full, Family, Junior, or Life member. (Please complete the **Horse Life Registration Form** and fax or mail to the USEA to avoid a \$10.00 phone-in processing fee). All forms can be found at www.useventing.com under "**Join Us! (Membership)**" and click on "**Forms & Documents.**"

Postage Note: The *Omnibus* and *Eventing USA* are mailed at the non-profit standard and periodical rate. The post office will not forward them if you move. Notify the USEA office at least six weeks before you move to continue to receive your publications at no charge.

- **LIFE MEMBER:** Entitled to all benefits of membership for the life of the member. This membership is not transferable. Receives a life subscription to the *Omnibus*, the bi-monthly *Eventing USA* magazine, *USEF Rules for Eventing*, life membership card and enjoys all voting privileges. **\$1,500.00 one time fee.**
- **FULL MEMBER:** Entitled to all benefits of membership for twelve months. Riders competing at the preliminary level and above must be a Life, Full, or Junior member. Receives a subscription to the *Omnibus*, six issues of the bi-monthly *Eventing USA* magazine, one copy of *U.S. Equestrian Federation Rules for Eventing*, membership card and enjoys all voting privileges. **\$85.00 a year.**
- **JUNIOR MEMBER:** Members may compete as Juniors up to and including the calendar year of your 18th birthday. In the year of your 19th birthday you will be required to upgrade to a Full membership for an additional \$25 (Born in 1990). Juniors are entitled to all benefits of membership for twelve months. Receives a subscription to the *Omnibus*, six issues of the bi-monthly *Eventing USA* magazine, one copy of *U.S. Equestrian Federation Rules for Eventing*, membership card and enjoys all voting privileges. Riders competing at the preliminary level and above must be a Life, Full or Junior member. **\$60.00 a year.**
- **FAMILY MEMBER:** Must live at the same address as a Full or Life member, cannot be added to a Junior membership. Enjoys all voting privileges and the right to compete at the Beginner Novice, Novice, and Training levels **only**. The household will receive one copy of the *Omnibus*, the bi-monthly *Eventing USA* magazine, *U.S. Equestrian Federation Rules for Eventing* and other select mailings. Family members may **only** compete at the Beginner Novice, Novice, and Training levels. **Limit four family members per household. \$60.00 a year per family member.**
- **NON-COMPETING MEMBER:** Receives a subscription to the *Omnibus*, six issues of the bi-monthly *Eventing USA* magazine, one copy of *U.S. Equestrian Federation Rules for Eventing*, membership card, and enjoys all voting privileges. Does not have the right to compete. **\$46.00 a year.**
- **SUBSCRIBING MEMBER:** Receives six issues of the bi-monthly association's magazine *Eventing USA*, membership card, and enjoys all voting privileges. Does not have the right to compete. **\$25.00 a year.**

ADDITIONAL INFORMATION

U.S. Equestrian Federation (USEF) Membership: The USEF requires that all owners, agents, lessees, trainers and riders of horses at USEF/USEA registered events competing at the Preliminary level or above must either be current members of the USEF, or pay a \$15.00 non-member fee, and a \$5.00 discipline fee at every competition entered. (Juniors and USEF Platinum members are exempt from the discipline fee). For USEF membership information please contact the USEF at (859) 258-2472.
